Waiver and Release of Liability and Indemnification

Please read this form carefully and be aware that in consideration for participation in this event, you will be expressly assuming the risk and legal liability and WAIVING and RELEASING all claims for injuries, damages or loss which you or your dog(s) might sustain as a result of participating in any and all activities connected with and associated with this event.

Warning of Risk

Dog activities are intended to provide a fun and rewarding experience for a dog(s) and its owner. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury, including death to either the dog(s) or its owner. Certain inherent risks include the propensity of any dog to behave in dangerous ways that may result in injury to another patron or dog(s). Other risks include, but are not limited to the inexperience, negligence or irresponsibility of a dog owner; the inability to predict a dog's reaction to sound, movements, objects, persons, or other animals; and actions by the dog(s) due to fright, anger, stress, insect bites, or natural reactions such as jumping, pulling, resisting and biting.
